

MINUTES OF THE 7th ACTION PLAN MEETING

Date: 08.01.2014

Place: Chamber of the District Judge, Udalguri.

In pursuance to the directions issued by the Hon'ble High Court in WP (C) Taken up No. 4299/2006, the seventh (7th) meeting of the revised Action Plan took place today at 4.15 PM in the office chamber of the District Judge, Udalguri. The Deputy Commissioner was present. The Superintendent of Police and was also present. The Chief Judicial Magistrate and Sri Obang Mize, Judicial Magistrate also participated in the meeting.

DISCUSSION AND THE RESOLUTIONS:

It was observed that the service of summonses as well as execution of warrants by the police in Udalguri district has improved satisfactorily. The Superintendent of Police was therefore appreciated for his efforts by the District Judiciary. But the monthly report Police Station wise and Percentage wise as decided in the last two meeting has not yet materialized. The Superintendent of Police has been requested to take follow up steps, for; this would further increase the service of process rate and would also provide data as regard police station(s) which is still lagging behind on this important topic for process service/execution.

The Superintendent of Police, Udalguri assured to submit Police Station wise and Percentage wise service of Summons and warrants in due time. The Superintendent of Police, Udalguri also assured that all efforts will be made in service of Summons and Warrants for upcoming National Lok Adalat to be held on 29/03/2014.

It is decided to remind the PWD (Building) Division to send the estimate pertaining to following

The Judicial Building and the official residence and quarters of the Judicial officers, Udalguri.

Construction of the ICT room

Conversion of the existing room for accommodating record room and library.

Installation of Collapsible gates etc./Extension and renovation of the court premises.

Implementation of decisions of District level Construction Committee's meeting on 17/12/2013.

The Superintendent of Police, Udalguri assured to send an expert within a short period of time to fix the location for installation of CCTV camera.

The Chief Judicial Magistrate, Udalguri expressed that report from the probationary officer of Juvenile Justice Board are coming regularly.

The Deputy Commissioner, Udalguri is requested to direct the probationary officer of the Social Welfare department to send the Social Investigation Report in each case regularly.

The Superintendent of Police, Udalguri assured to review the security aspect of the Court premises and quarter of the Judicial officers of District Judiciary.

With the above discussion, the meeting ended. Inform all concerned.
