Deputy Commissioner, Udalguri is also requested to submit a list of cases to be taken up at the National Lok Adalat.

✓ The members present also discussed about the problems of inmates in District jail and the member present discussed that, a permanent Medical Officer is required for the District Jail, Udalguri. In this regard Deputy Commissioner Udalguri has assured that she will inform the matter to the I.G prison, Govt. of Assam.

- The meeting present also resolved to inform the Director of Social welfare for conducting the meeting of Juvenile Justice, Board, Udalguri by sending a copy of this meeting.

The judicial officers present also discussed about the unavailability/non production of seized articles in the Malkhana of the court during the trial and requested Deputy Superintendent of Police to intimate the request of the officers to the Superintendent of Police for his direction to I.O for sending seized articles along with the charge sheet.

The officers present also requested the Superintendent of Police, Udalguri to depute an officer in the rank of Sub Inspector of Police as the Prosecuting Sub Inspector (PSI) at Udalguri.

Lastly the member present resolved to send a copy of this meeting to all the concerned authorities for information & necessary action.


