Terms and Conditions:

1. The candidates must be citizens of India as defined under Articles 5 and 6 of the Constitution of India and must not be less than 18 years and more than 40 years of age as on 01.01.2023.
2. Candidates must submit their applications in the standard format along with self-attested copies of all testimonials regarding educational qualification, age and experience (if any). The candidates should paste his/her recent passport size photograph in the given space of the application. 2 (two) more copies of passport size photographs, duly signed by the candidates on the back side, should be stapled on the top right corner of the application form.
3. Envelope containing the application form should indicate the name of post applied for on the top in block letters as "APPLICATION FOR THE POST OF PEON or CHOWKIDAR" (whichever is applicable).
4. The application shall be addressed to: The Office of the Chief Judicial Magistrate, Udalguri, P.O & Dist- Udalguri, Pin-784509, Assam, and may be sent by post. The candidates may also submit their applications by hand directly in the drop box kept in the Office of the Chief Judicial Magistrate from 10.00 am to 5.00 pm on the working days.
5. The candidates shall have to mention their mobile numbers in the application.
6. Candidates applying for both the posts should submit separate applications.

7. Candidates who are already in Govt. Services must apply through proper channel and shall have to produce 'No Objection Certificate' from the employer on the date of interview, if shortlisted for interview.
8. After preliminary scrutiny of applications, the provisionally eligible candidates have to appear in Interview/Viva voce.
9. Date and place of interview and list of eligible candidates will be notified in due course in the official website of Udalguri District Judiciary (www.udalgurijudiciary.gov.in). No separate call letters will be issued to the candidates for the interview/viva voce. Hence candidates are advised to visit the said website regularly.
10. If any candidate is found to have suppressed his/her educational qualification or submitted any false information at the time of applying for the post(s), his/her candidature shall be liable to be rejected or terminated.
11. Incomplete applications in any aspects, for example, applications without proper supporting documents/photographs or incomplete applications/unsigned applications will be summarily rejected.
