Instructions for candidates who are appearing in the Interview for the posts of Peon and Chowkidar:

1. All provisionally eligible candidates are to report at the venue for interview on the date and time as mentioned above.

2. Candidates are directed to bring their testimonials of educational qualification, valid Employment Exchange Card, Age proof, experience certificate (if any) and Identity proof in original for verification. If any candidate submits false/forged document, he/she will be disqualified and legal action will be taken against him/her.
3. Candidates are also directed to bring two passport size coloured photographs on the date of interview as some candidates have not submitted 3 (three) photographs along with their applications.
4. Candidates appearing in the interview shall have to make a declaration regarding their educational qualification as per the format to be supplied to the candidates on the date of interview. If on verification, if it is found that any candidate has suppressed his/her educational qualification or made false declaration, his/her candidature shall be rejected.
5. No separate call letter will be issued for appearing in the interview.
6. No TA/DA will be paid to the candidates for appearing in the interview.
7. The decision of the Selection Board in all matters would be final and binding on the candidates.
8. Canvassing in any form for selection shall render the candidate disqualified.
9. Applications are still under scrutiny and candidature of a candidate may be rejected at any time, if found ineligible.
